- I. The candidate can apply for more than one post out of the enlisted Departments separately but, they have to apply separately from different posts.
- II. Written / Viva-voice will be conducted if the number of candidates are more. However, there will be no written test for the post against which less number of applications are received than the vacancies. Director, AIIMS, Bhubaneswar will have the discretion to decide for which post written examination to be conducted and for which post there will be no written examination. The decision there of will be final.
- III. The merit list (selected and waiting list) will be prepared on the basis of combined marks of written test and personal interview or only Personal Interview.
- IV. Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidates, post will be offered to the candidates from waiting list according to the merit panel. All applicants must provide latest mobile numbers and e-mail for timely communication.

Online applications with complete bio-data are invited from Indian citizens for admission to the **Fellowship in Public Health Nutrition under the Department of Community Medicine & Family Medicine** for a maximum tenure period of one year (01) at the AIIMS, Bhubaneswar for the Academic session July 2020, in the prescribed format, as available on the website <https://www.aiimsbhubaneswar.edu.in>.

Candidates who are fulfilling all eligibility criteria as mentioned below may apply through online in the prescribed format. Candidates who are working in government/ Private agency may intimate their employer about their submission of application. 1. A written Examination based on MCQs in **Fellowship in Public Health Nutrition** (total marks 80) will be conducted if more than 10 candidates apply. The exact date, time and place will be intimated in due course of time through our Institute website.
2. Candidates who get 50% marks or more in the written examination will be eligible for consideration for the Interview. The total number of candidates called for the interview will be maximum of three times the number of seats.
3. The result of the written examination will be displayed on the notice board of the Examination Section at AIIMS and the Interview will be held on date announced on website. Candidates will be sent intimation about the written examination and/or personal interview through email.
4. The Interview will carry 20 marks to be based on field activities / experience related to Public Health Nutrition. There is no cut off mark for the Interview.
5. The merit list(s) shall be prepared on the basis of combined marks of written test and interview.
6. After filling of available posts all remaining candidates shall be kept in the waiting list that is valid till **31st December 2020**.
7. If insufficient number of candidates are eligible, then the written examination may not be held as per institute guidelines - selection will be based on Interview only.
8. Prior experience (research or field) in **Public Health Nutrition** or related areas of Nutrition will be given preference in selection process as decided by the Committee.
9. In case of exceptional candidates, the discretion of Authorities to relax requisite eligibility criteria like age, experience etc. shall be final.
